- Gulf CDC's data sharing policy is a working example of enabling safer, faster, and smarter public health action at scale.






Using PEARLS As Implementation Pathway

Cross-Border Health Data

 Public health data sharing (e.g., disease surveillance) <u>demands</u> legal, ethical, and regulatory alignment.





PEARLS provides a safe, trusted foundation and offers a pathway to implement this vision.

Each PEARLS dimension reduces harm and builds trust in public health systems powered by data and digital tools

Turning Principles into Action



Gulf CDC used PEARLS as a practical tool to move from theory to action in building the Gulf data sharing policy.

Why This Matters – Trust maximization and Harm minimization

The experience shows that good governance isn't a barrier but it's the foundation for safer, smarter innovation.

The PEARLS-guided approach:

- Minimizes potential harm by anticipating risks before they happen,
- Builds trust among countries, individuals, clinicians, and the public
- **Enables rapid, coordinated action** even in the world's most challenging settings





PEARLS Domain	Gulf CDC	
Political	Secured ministerial agreement for rapid, cross-border reporting and data sharing	
Ethical	 Verifying the data with the concerned country Countries understanding of the data usage and utilization 	
Administrative	Unified reporting channels and outbreak response protocols	
Regulatory	Standardized notification rules and criteria	
Legal	Aligned data protection and confidentiality regulations with internationally adopted standards	
Social	Inclusive communication with all member countries and the outcome of the data sharing is to benefited all the countries	

International Patient Summaries (IPS) "digital passport"

- A global digital health standard IPS is an internationally recognized, standardized summary of a person's key health information, designed for safe, rapid sharing, especially during cross-border care or emergencies.
- What does it include?
 Allergies, medications, major health conditions, procedures, immunizations, and other essential data, and presented in a simple, portable format.
- Why does it matter?
 Enables healthcare providers to make informed, timely decisions, even if the patient's full record is unavailable or they're far from home.

IPS involves collecting and sharing sensitive patient information. **PEARLS** ensures that, when **IPS** is used, there are clear rules about who controls the data, how privacy is protected, and that all actions meet ethical and legal standards.





PEARLS	IPS in Action	
Political	Requires international cooperation to ensure recognition and adoption of the IPS	
Ethical	Respects patient autonomy and confidentiality in data sharing	
Administrative	Simplifies clinical workflows, making it easy for providers to access and use safely	
Regulatory	Aligns with global standards for health information exchange and patient safety	
Legal	Enforces compliance with privacy laws, data protection, and clear patient rights	
Social	By respecting ownership and privacy, IPS builds trust-patients know their information is used only for their care, and providers are confident they're acting within ethical and legal guidelines.	



GCC Experience is a Starting Point, Not the Finish Line

- What we've built in the Gulf CDC shows what's possible, but these lessons aren't limited to GCC context.
- The tools, principles, and governance models can be adapted anywhere and for multiple purposes.

"Beyond"	Example	Future Potential
Mass Gatherings	Hajj, Olympics, World Expo	Routine travel, migration, trade
Regional Borders	GCC cross-border data policy	Global health networks (for both emergencies and routine care)
International Patient Summaries	IPS piloted at Hajj	Integrated digital health records (patient-centered health) real-time, interoperable, and portable health information.










Gulf Observatory (GO)

- Establishment of an integrated health observatory system (communicable diseases, non-communicable diseases, registries, and national surveys) to improve the quality and accessibility of health data across member states, thereby enhancing public health decision-making and regional collaboration.
- Utilizing AI for health and public health research.
- Incorporating WHO 2021 guidance on ethics and governance of AI for health, and 2024 WHO guidance on large multi-modal models that sets key principles and recommendations to guide AI responsible use in health
